The Management Board of Polskie Górnictwo Naftowe i Gazownictwo SA ("PGNiG") publishes estimates of selected operating data for twelve months of 2014 and the fourth quarter 2014, i.e.:

The volume of sales outside the PGNiG Group includes the following companies: PGNiG SA, PGNiG Sales & Trading and PGNiG Obrót Detaliczny. For PGNiG SA and the PGNiG Group, data on this volume for the current quarter and twelve months are not comparable with the corresponding periods of the previous year due to commencement of operations by PGNiG Obrót Detaliczny (August 1st 2014) and higher sales through the Polish Power Exchange.

Considering the reduced supply of gas from the eastern direction in the period from September to December 2014, the imports volume shown above (8.1bn cubic metres) fulfilled the contractual obligations relating to minimum annual volumes (under the take-or-pay clause).

PGNiG informs that as at December 31st 2014 its stocks of gas (including mandatory stocks managed by the Minister of Economy) stored in underground high-methane gas storage facilities (i.e. Brzeźnica, Husów, Strachocina, Swarzów and Wierzchowice; as well as cavern facilities Mogilno and Kosakowo) was approx. 2.06 billion cubic meters. This volume of gas stocks does not include the volume managed by Operator Systemu Przesyłowego GAZ-SYSTEM SA.

The above data are estimates and may differ from the actual data, due to be disclosed on March 5th 2015 with the publication of the interim report.
