



**Independent registered auditor's report
on the review of the interim condensed separate financial statements
for the period from 1 January to 30 June 2017**

To the General Shareholders' Meeting and the Supervisory Board of CIECH S.A.

Introduction

We have reviewed the accompanying interim separate financial statements of CIECH S.A. (hereinafter called *the Company*), with its registered office in Warsaw, Wspólna 62 Street, comprising the interim separate statement of financial position as at 30 June 2017 and the interim separate statement of profits or losses, the interim separate statement of other comprehensive income, the interim separate statement of changes in equity, the interim separate statement of cash flows for the period from 1 January to 30 June 2017 and notes, comprising a summary of significant accounting policies and other explanatory notes.

Management is responsible for the preparation of these interim condensed separate financial statements in accordance with the International Financial Reporting Standards as adopted by the European Union related to interim financial reporting (IAS 34) is the responsibility of the Company's Management. Our responsibility is to express a conclusion on these interim condensed separate financial statements based on our review.

Scope of review

We conducted our review in accordance with International Standard on Review Engagements 2410, *Review of Interim Financial Information Performed by the Independent Auditor of the Entity* as adopted by the National Council of Certified Auditors as the National Standard on Audit and Assurance 2410 with a resolution dated 10 February 2015. A review of interim condensed separate financial statements consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures.

A review is substantially less in scope than an audit conducted in accordance with International Standards on Auditing as adopted by the National Council of Certified Auditors as the National Standards on Audit and Assurance. Consequently, it does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.
