CURRENT REPORT

As at June 30th 2020 PGNiG's stocks of gas (including mandatory stocks managed by the Minister responsible for energy) was approx. 2.8 billion cubic meters measured as high-methane gas equivalent with a calorific value of 39.5 mJ/cm. The volume of gas stocks includes high-methane and nitrogen-rich gas stored in Poland and abroad as well as LNG terminals. The data do not include the volume managed by Operator Systemu Przesyłowego GAZ-SYSTEM SA.

The above data are estimates and may differ from the actual data due to be disclosed with the publication of the interim report on August 20th 2020.
