- for profit and loss account items and for cash flows items an exchange rate calculated as the arithmetic average value of exchange rates announced by the National Bank of Poland as at the end of each month of 3 quarters 2021 and 3 quarters 2020: 1 EUR = 4.5585 PLN and 1 EUR = 4.4420 PLN respectively,
- for dividend calculation arithmetic average values of exchange rates announced by the National Bank of Poland as at the last day of each month of 2020 1 EUR = 4.4742 PLN.
