Acting in accordance with Article 87 Section 1 item 2b of the Act of July 29th, 2005 on Public Offering, Conditions Governing the Introduction of Financial Instruments to Organised Trading, and Public Companies (Journal of Laws 2009, No. 185, item 1439, as amended) we hereby notify you that, as a result of acquisition of shares of CD Projekt S.A. stock, LEI code: 259400TYO5Q8SH8TL437 (“the Company”) in the course of a transaction carried out on the Warsaw Stock Exchange on July 5th 2024, the funds managed by Nationale-Nederlanden Powszechno Towarzystwo Emerytalne S.A., namely Nationale-Nederlanden Otwarty Fundusz Emerytalny, Nationale-Nederlanden Dobrowolny Fundusz Emerytalny, Nationale-Nederlanden Dobrowolny Fundusz Emerytalny Nasze Jutro 2025, Nationale-Nederlanden Dobrowolny Fundusz Emerytalny Nasze Jutro 2030, Nationale-Nederlanden Dobrowolny Fundusz Emerytalny Nasze Jutro 2035, Nationale-Nederlanden Dobrowolny Fundusz Emerytalny Nasze Jutro 2040, Nationale-Nederlanden Dobrowolny Fundusz Emerytalny Nasze Jutro 2045, Nationale-Nederlanden Dobrowolny Fundusz Emerytalny Nasze Jutro 2050, Nationale-Nederlanden Dobrowolny Fundusz Emerytalny Nasze Jutro 2055, Nationale-Nederlanden Dobrowolny Fundusz Emerytalny Nasze Jutro 2060 and Nationale-Nederlanden Dobrowolny Fundusz Emerytalny Nasze Jutro 2065, collectively increased the share of Company stock in their possession to beyond 5% of votes at the General Meeting of the Company.
